SAE SPONSORSHIP RULES AND REGULATIONS

1. **Sponsorship Payment** – A deposit of at least fifty (50) percent of the total sponsorship amount must accompany this agreement. The balance of the total sponsorship amount is due no later than **January 1, 2002** by the customer prior to the opening date of the exhibition. Failure by the customer to pay the total sponsorship amount by the due date may be considered a cancellation of sponsorship by the SAE Exhibition Management and may result in the customer being prohibited from participation in the exhibition. Purchase orders will not be recognized as an acceptance of the sponsorship agreement.
2. **Cancellation of Sponsorship**– In the event of a sponsorship cancellation and SAE receives notice of such cancellation more than ninety (90) days prior to the opening date of the exposition then SAE shall retain a service charge equal to 50% of the total sponsorship amount. Within ninety (90) days of the opening day of the exposition, the customer is liable for 100% of the total sponsorship amount.
