JCASO Mission and Functions

• Maintain a trained, technically competent, deployable cadre of acquisition experts who remain operationally focused and are able to chop to a COCOM upon order.

• 27 permanent military, civilian and contractor personnel with expertise in: planning; contingency contracting; contingency financing; contract law and civil engineering

• Provide COCOM's an element aligned with the theater chain of command tasked with:

• Acquisition program management during combat operations, post conflict operations and contingency operations.

• Providing Joint focus and cross service coordination in theater

- Providing initial contract management
- Contract coordinating element for LOGCAP/AFCAP/CONCAP
- Providing a clearing house for contract actions above pre-defined thresholds
- POC for all contracting and contractor issues in the JOA

• Transitioning to the Joint Contracting Command providing smooth transition into phase 4, stability and reconstruction operations

• Participate in COCOM exercises to refine CONOPS and review of OPLANS, CONPLANS in concert with the Joint Operational Contract Support Planners (JOCSP)





Congressional Direction Sec 854 of NDAA of FY 07

MEMORANDUM FOR SECRETARIES OF THE MILITARY DEPARTMENTS CHAIRMAN OF THE JOINT CHIEFS OF STAFF UNDER SECRETARIES OF DEFENSE COMBATANT COMMANDERS

SUBJECT: Joint Contingency Acquisition Support Office (JCASO)

To comply with SECDEF's Guidance for Development of the Force: Fiscal Years 2010-2015 and Congressional mandates in NDAA 07 and NDAA 08, an organization is being established to orchestrate, synchronize, and integrate program management of contingency acquisition across COCOMs and USG agencies, during combat operations, post-conflict operations, and contingency operations. This memorandum provides information on the establishment of this organization.

The new organization will be called the Joint Contingency Acquisition Support Office (JCASO). The JCASO will provisionally reside within the Defense Logistics Agency and be provisionally located at the Defense Depot Norfolk, Virginia. An Initial Operational Capability will be established by FY2009.

Where We Were 2006

• World class fighting force highly dependent upon contractors as a result of:

- Shift to an all volunteer force
- Effort to capture a "peace dividend"
- Selected transition to performance based logistics
- Limited acquisition oversight:
 - Reduction of acquisition personnel in all Services and Agencies
 - Poor career development lack of senior billets to ensure advancement
 - Little Joint coordination
- Incorrect assumptions with respect to current operations:
 - Short war
 - Incomplete Phase IV planning
 - Assumed conduct of contract administration and oversight could be accomplished outside the AOR
- GAO Report "High-Level DoD Action Needed to Address Long-standing Problems with Management and Oversight of Contractors Supporting Deployed Forces," December 18, 2006
- Limited accountability and visibility of contractors
- Initial publication of DoDI 3020.41"Contractor Personnel Authorized to Accompany the U.S. Armed Forces"

• JCASO responds to NDAA direction on acquisition process and contractor personnel in a JOA.

- Provide Commander's acquisition guidance to multiple components, coalition forces and other governmental agencies.
- Synchronize civil augmentation capabilities in theater (LOGCAP, AFCAP, CONCAP, Executive Agencies), maximize efficiencies, minimize costs, enhance support and reduce competition for resources.
- Participate in boards, centers and cells as required to advance the COCOM/JTF Commander's intent.
- Communicate and enforce COCOM/JTF Commander's intent on all contingency contracting matters to contracting elements.




JCASO – Value Added

- Manage acquisition related CCIR's
- Enhance the JTF Commander's operational control of the theater contractor workforce.
- Provide oversight to contract administration elements to ensure visible and dynamic contract administration is being conducted.
- A resource for theater opening as required.
- Rationalize acquisition planning, manning and training efforts across the COCOMs and Services, advance efficient and cost effective procedures, processes and "best practices".
