Subject: IAQG OASIS Changes Affecting NAB's and CB's

The following changes are being implemented January 29, 2009 in IAQG OASIS (<http://www.iaqg.org/oasis>).

1. If the status of a CB's accreditations is changed to "Withdrawn/Expired", OASIS will automatically change the status of all the "Certified" supplier certificates to "CB Withdrawn/Expired", for the certificates issued by that CB and identified as the "latest certificate" for that Supplier. If the status of the CB's accreditations is reactivated, this process will be reversed.
2. OASIS will now include both Aerospace Auditors (AA) and Aerospace Experienced Auditors (AEA).
 - a. Note to NAB administrators – For the existing AEA's, NAB administrators will be required to enter the AEA start date before managing the approvals.
 - b. Note to CB's – OASIS now provides the ability to enter AA data and link to the assessments entered.
3. The existing "Feedback to CB's" application has been modified to enable users to also give feedback to the CB's directly, without first finding the supplier in the Certified Supplier Directory.
4. When a user is giving feedback to a CB about a specific selected supplier in the Certified Supplier Directory, the user will now be able to select if they want to send a copy to the supplier with the communication. Previously the copy to the supplier was always sent.
5. When entering Recertifications, CB's can now select if each site in the assessment was "assessed". Previously all sites were identified as "assessed". The reason for this is that in some exceptional cases not all sites are assessed.
6. The administrator doing the data entry for a CB will now get a copy of the outgoing emails to the Supplier Administrator when requesting a new supplier setup. This will enable follow-up with the Supplier Administrator about the status of the request, outside of OASIS.
7. The CB listing in the Data Search section of OASIS has been modified to include the accreditations and status for each Family of Standards (9100, 9110, 9120) on the main listings page.
8. A new "Aggregate Reporting" application will be available to CB's to enable them to compare per element the average number of Major and minor non-conformities to the overall aggregate averages in the following categories:
 - i. Per Auditor (aggregate average for each auditor for assessments by that CB)
 - ii. Per Country (aggregate average for all CB's in that country)
 - iii. Per Sector (aggregate average for all CB's in that sector)
 - iv. Global (aggregate average for all OASIS entries)

NAB's will also be able to access this application for the CB's they manage.

This application will initially be implemented for users with access to the "Manage Users" application for CB's and NAB's. These users can then grant access to other users as needed.
